Copy of the Will of Mr William Brower

In the Name of God Amen. I William Brower of the City County and State of New York. Yeoman being Weak in body but by Gods Grace of Sound Mind and Memory blessed be Almighty God for the Same. Do make this my last Will and Testament in Manner and Form following First I give or Bequeath my Immortal Soul to my Creator and my Body to Christian Burial I then Order and Direct all my Debts and Funeral Expences to be fully Discharged Paid and Settled I then Give and Bequeath my Eldest Son by Name Calib Bell Brower the One Eighth Part of my Estate being Wheresoever it may be found Item I give and Bequeath unto my Second Son Jeremiah Brower the Same or one Equal Eighth Part of my Estate 2 Item My Son Daniel Brower I also Give and Bequeath Another Eighth Part of Estate 3 Item my Son Jacob Brower I also Give and Bequeath Another Eighth Part of my Estate 4 My Son John Brower I also Give Another Eighth Part of my Estate 5 Item my Son William Brower I also Give and Bequeath Another Eighth Part of my Estate 6 My Son Nicholas Brower I also Give and Bequeath Another Equal Eighth Part of my Estate 7 they each Paying their Proportionate part of the Money to Prosecute for the Same the other Eighth Part I desire to be Equally divided Between my three Daughters Namely Caroline Amy and Sarah or the Respective Heirs of their Bodies for ever and Lastly I do hereby Nominate my two Sons Daniel and John Browers as my Executors to this my Last Will and Testament as Witness ~~whereof~~ I have hereunto Set my hand and Seal this 26 day of June 1849
